

**Cummings Township Supervisors
Reorganizational Meeting Minutes**

JANUARY 3, 2012

The reorganizational meeting was called to order by Walt Braddock at 7:00 PM. Supervisors John Gasperine and Tom Thompson present. Also present at the meeting was Roadmaster Rick Bierly and Solicitor Scott Williams. Will Wolfe, Zoning officer and Lucy Cox were also present.

Attendance from the public was Carl Frech.

The meeting was called to order by Walt Braddock.
First order of business were appointments for positions.

Walt Braddock rescinded his letter of resignation and a motion was made By Tom Thompson to bring Walt back immediately as an appointed Supervisor. John Gasperine seconded the motion. This position will go on The ballot at the next election. Whoever is elected will fulfill the term. Walt Braddock was nominated for chairman. Tom made a motion and John Seconded. Tom Thompson was nominated as temporary chairman. Walt made a motion and John seconded. Lucy Cox was nominated as secretary/ Treasurer. Walt made a motion and Tom seconded. The compensation for The position was set at 650.00 per month. Bond for secretary/treasurer was Set at 125,000.00. Walt made a motion to stay with Jersey Shore State Bank And John seconded. Motion was made by Tom to retain Scott Williams as the Solicitor and John seconded. There was a recommendation by the solicitor to Go to the auditors to set John Gasperines hourly rate as a township employee. Motion was made by Tom and seconded by Walt. Motion was made by Walt To reappoint Will Wolfe as Zoning Officer. Compensation was set at 175.00. John seconded. The position of sewage enforcement officer was tabled. The Township will retain Jamie Nolan temporarily to renegotiate costs and seek Additional income for Township. John made the motion and Tom seconded. Carl Frech was recognized to speak by the board on this issue. A motion was Made to establish a new contract with Jamie. John made the motion and Tom Seconded. Richard Bierly was reappointed as Roadmaster. Walt made the motion and Tom seconded. The salary for roadmaster was set at 12.00 an hour. John made a motion to table rate review resolution. Tom seconded. The motion was made to change the date of January's monthly meeting. Tom made the motion and John seconded. The new date is Jan.18,2012.

The secretary will advertise this change in the Sun-Gazette. The motion Was made to affirm the Liquid Fuels Program 2011 by Tom and seconded By Walt. The Supervisors were in agreement to use the Roadmaster's Judgement in the snow removal for the winter of 2012. The motion was made For the Right to Know officer and Lucy Cox was nominated. John seconded. The motion was made by Tom to retain Bub Rainey Vice Chairman of the planning commission. John seconded. The motion was made by Walt and seconded by Tom to increase the recreation advisory board from seven to nine. Richard Bierly and Brandi Martin were added to the board. Toner Hollick was retained Chairman. The motion was made to affirm to pay for Workshops for training and travel expenses. The mileage rate for travel was Set at 55.5 cents per mile Tom made the motion and Walt seconded. The motion was made by John and seconded by Tom to retain the safety deposit Box. The motion was made by Tom and seconded by Walt for Lucy to do an Inventory on the fixed assets of Cummings Township. Tom made a motion for the meeting to adjourn and Walt seconded. The meeting ended at 9:45 P.M.
